We are changing our name to Behavioral Health to reflect the move to integrate our mental health and substance use disorder programs. In the upcoming months, we will be converting our public facing materials to reflect this change.

Welcome Carlos Palacios!

The Santa Cruz County Board of Supervisors conducted a nationwide search to find a replacement for Susan Mauriello as County Administrative Officer (CAO) for Santa Cruz County. Ms. Mauriello retired in July after 27 years on the job. The Board selected Carlos Palacios! He was the County's assistant county administrative officer since 2015, after being the Watsonville City Manager for 19 years.

The CAO is the highest ranking staff of the County, and is responsible for the preparation and supervision of the County's budget, legislative analysis, contract and grant administration, intergovernmental relations, supervision of non-elected department heads, and oversight of all departmental functions. The County Administrative Officer is responsible for management, review, and recommendations related to the Board of Supervisor's weekly meeting agendas.

Mr. Palacios is a native of New Mexico, but has lived in Santa Cruz County for 25 years. He holds degrees from the University of Albuquerque and Princeton University. He is the first Latino to hold the title of CAO in Santa Cruz County.
