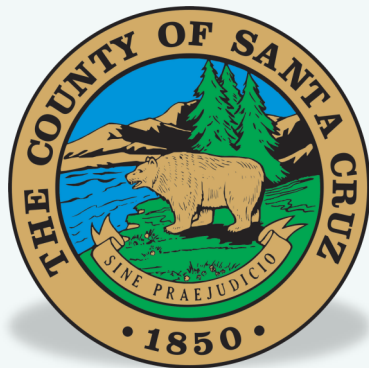

General Information

Introduction to the Provider Directory

This provider manual is designed to share information about all Mental Health Plan service options for Behavioral Health Services in Santa Cruz County and the providers which deliver them to beneficiaries. It also includes information about how to access care.

In order to receive services, you must be enrolled or eligible for Medi-Cal, and meet medical necessity. For more information about eligibility and medical necessity, please see the Beneficiary Handbook found at <http://www.santacruzhealth.org/Portals/7/Pdfs/Beneficiary%20Handbook%202017.pdf>

If you are not eligible for Medi-Cal, and would like information about other substance use disorder treatment options, you may contact County Behavioral Health at (831) 454-5287.

Emergency Services

Emergency Services are available 24 hours per day and 7 days per week. If you are experiencing a health-related emergency, **please call 911 or go to the nearest emergency department for help.**

Accessing Services

Many people have difficult times in life and may experience mental health needs. The most important thing to remember when asking yourself if you need professional help is to trust yourself.

If you are eligible for Medi-Cal, and you think you may need professional help, you should contact the toll-free **24 hour per day, 7 day per week** Access Line at (800) 929-2335 to request an assessment.

You may also be referred to the Santa Cruz County Behavioral Health in other ways. The County accepts referrals for mental health services from doctors or other primary care providers who think you may need services, and from your Medi-Cal health plan. Usually a provider will need your permission, or the permission of the parent or caregiver of a child, to make a referral, unless there is an emergency.

Other people and organizations may also make referrals to the County including schools, social service departments, conservators, guardians, family members, and law enforcement agencies.

Alternatively, if you prefer to speak with a provider directly, you may connect with them using the information found in this Provider Directory.

If your child or teenager is struggling with mental health needs, you may use the Access Line at (800) 952-2335 to discuss your concerns and arrange for an assessment.

If you or someone you know is experiencing severe or life-threatening symptoms **dial 911 immediately or go to the nearest emergency department**. Emergency services are covered by Medi-Cal 24 hours a day, 7 days a week, without requiring any authorization.





Service Options

The Mental Health Plan offers a range of service options for adult and adolescent beneficiaries based on their medical necessity. The services are designed to provide help for mental health needs beyond what a primary care doctor can provide.

- Assessment and Evaluation
- Individual and Group therapy
- Crisis Intervention
- Coordinated Care Treatment Teams
- Medication Management
- Prevention and Early Intervention Services
- Supportive Housing
- Independent Living Skills





Service Options

Service Options for Children & Adolescents

The range of services available for adolescents include:

- Assessment and Evaluation
- Individual, Family, and Group therapy
- Crisis intervention
- Coordinated Care Treatment teams
- Juvenile Probation Wraparound and Evening Center
- Intensive Home-Based Services
- Medication Management
- Prevention and Early Intervention Services
- Independent Living Skills
- Residential Treatment (subject to prior authorization by the County)

All of the services listed above are available from providers within the County of Santa Cruz, with the exception of adolescent residential treatment. Any adolescent beneficiary eligible for residential treatment can be placed with service providers outside of the County through our agreements with those counties.
