Special Outreach Strategies to Education and Parents/Community:

- **Continue to work through our clinicians to have survey information about personal/system needs from parents filled out** (eg., revised family survey that focuses on one question to parents--to increase return rate we must simplify). **This may be best way to reach parents with limited time availability!**
