COVID-19 Case Trends - Masks Are Strongly Recommended

COVID-19 case rates are starting to decrease in Santa Cruz County. Public Health's surge response will focus on supporting the healthcare system, supporting the community with COVID-19 preparedness, and maintaining Public Health operations. The 14-day change graph to the right indicates a flattening and decreasing trend.

• Reproductive number median estimate is below 1, which indicates that transmission is not increasing.

Individual behaviors **DO** make a difference to **SLOW** the spread. What you can do during the **Omicron surge:**

• Get vaccinated and boosted.

- Upgrade vour masks.
- Improve ventilation and air filtration.
